ABOUT TTAD'S AGENCY PARTNERSHIP PROGRAM

- In 2011 TTAD began a program of Community Sponsorships, which included a \$25,000 budget in support of local qualifying organizations, thru District provided services, and/or cash sponsorship funding amounts of up to \$500 per year
- The initial TTAD Board concept for an expanded program (promoting beneficial and larger community Agency Partnership collaborations between TTAD and other local public agencies and nonprofits) came about after the District successfully partnered with the Truckee Fire Protection District in 2014-2015 purchasing a \$500,000 Aircraft Rescue & Fire Fighting (ARFF) truck
- TTAD also partnered with the Truckee Donner Recreation and Parks District in 2015-2016 with a \$945,000 partnership funding of the community Aquatic Center
- For 2021 TTAD's approved budget includes \$1,000,000 to be split between their Agency Partnership, Transportation, and Housing Programs, with the board having the ability to allocate funds between them as they see fit

Fill out Letter of Intent (LOI) - online
Notified if the submittal LOI was approved
If approved - invited to apply
Committee reviews proposals
Notified if application was approved

Phase I - LOI Process

•	Opens immediately after workshop	Sep 8 3 pm PDT
•	Open for submissions	Sep 8-21
•	Internal review and due diligence	Sep 21-23
•	Committee decisions and notify finalists	Sep 24-30

Phase II - Full Application

•	Open for full proposal submission	Oct 1-29
•	Committee members review proposals	Nov 2-16
•	Committee meeting(s) / decision making	Nov 17-22
•	TTAD Airport Board of Directors meeting	Dec 1
•	Notification of funding decisions	Dec 2
