#### STAY CURRENT

- Information changes often. What's true one moment may be updated the next
- Text alerts from 211 will notify you of new information
  - NEVADA COUNTY text VACCINEINFO to 898211
  - PLACER COUNTY text PLACERVACCINE to 898211
- The State of California is rolling out **My Turn**, a single centralized COVID-19 vaccine sign-up. It will become operational in Nevada County and Placer County in the coming weeks. Sign up now at <a href="https://myturn.ca.gov/">https://myturn.ca.gov/</a>

### **VACCINE APPOINTMENTS FOR ELIGIBLE RESIDENTS**

- If you are part of a healthcare system, check first for info within those systems. Most of them are notifying eligible patients at this time. A number of pharmacies are scheduling appointments independently
- Some vaccine clinics have proof of residency requirements
  - Valid CA driver's license or CA ID card
  - Home utility bill (including cellular phones)
  - <u>DMV list of acceptable documents</u> for reference

- Vaccine clinics for people in current Phase/Tier ONLY
- FAQs County of Placer COVID-19 Public Health Vaccine Clinic in Roseville at The Grounds
  - Appointment CANCELLATION emails in Placer County
    - If people receive a cancellation email from the County of Placer, they can reply to the email directly with
      questions. The County sends cancellation notices to those whose entered information does not meet eligibility
      criteria
    - If they receive a cancellation from Safeway or others, they should contact that provider directly
